The Government of Nepal [GoN] has allocated funds towards the cost of **Municipality Building construction** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Municipality Quarter Building ,Panchkhal**, contract Identification No: **BC/W/NCB/PM/01/073/74**. Bidding is open to all eligible Nepalese Bidders.
2. Ministry of Federal Affairs and Local Development, Office of Panchkhal Municipality, Panchkhal, Kavrepalanchowk invites sealed bids from eligible bidders for the Construction of Municipality Quarter Building of Panchkhal Municipality under National Competitive Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding: **At least One similar Building construction project having minimum project cost of NRs. 2 million that have been successfully completed.**

4. A complete set of Bidding Documents may be purchased from the **Office of Panchkhal Municipality, Panchkhal** by eligible Bidders on the submission of a written application, along with the attested copy of company/firm registration certificates all valid, Tax Clearance certificate up to F/Y 2072/073 and self declaration certificate and upon payment of a non-refundable fee of **NRs. 1,000.00** till 30<sup>th</sup> day of notice published at office hour cost of NRs. **1,000.00**.

5. Sealed bids must be submitted to the **Office of Panchkhal Municipality, Panchkhal-Kavrepalanchowk** by hand on or before **12:00 Noon** on 31<sup>st</sup> day of notice published. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00pm** on 31<sup>st</sup> day of notice published at the **Office of Panchkhal Municipality, Panchkhal- Kavrepalanchowk**. Bids must be valid for a period of **90 days** after bid opening. If Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Single Deposit account No.: **1040303000005** of **Office of Panchkhal Municipality, Panchkhal- Kavrepalanchowk** at **Ratriya Banijya Bank, Dhulikhel** and submit the receipt of the deposited amount of cash along the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
9. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
